



NOTICE OF PUBLIC COMMENT HEARING

DOCKET NO. 24-00089-UT, IN THE MATTER OF THE APPLICATION OF PUBLIC SERVICE COMPANY OF NEW MEXICO FOR REVISION OF ITS RETAIL ELECTRIC RATES PURSUANT TO ADVICE NOTICE NO. 625

The New Mexico Public Regulation Commission (“Commission”) gives notice of a Public Comment Hearing in the above-listed matter, scheduled for **Wednesday, January 15, 2025, from 4 p.m. to 7 p.m.** at the New Mexico 811 building, located at **1021 Eubank Blvd. NE, Albuquerque, NM 87112.**

Any interested persons who are not affiliated with any party, may make oral comment in person, via the Zoom app, or by telephone. Persons making oral public comments in person do not need to sign up in advance but do need to sign in by hand on the sign-up sheet at the New Mexico 811 Building.

Individuals wishing to comment must sign up by contacting Patrick Rodriguez at public.comment@prc.nm.gov or (505) 490-7910 as soon as possible before the start of the public comment hearing. When sending an email to sign up for public comment, please identify the name of the commentor, the name of the organization the commentor represents (if any), and the topic or issue on which the commentor desires to comment. The comment order shall be based on the order in which commentors sign up, but public officials may be taken out of order. If a commentor is not present at the time the commentor is called to provide comment, that commentor shall forfeit the opportunity to provide public comment. Each public comment shall be limited to no more than three (3) minutes unless the Commission acts to extend the duration. Individuals represented by or representing a common organization or association may be asked to select one individual to act as spokesperson to provide comment for the group as a whole. Individuals who sign up to comment, but either fail to do so or choose to speak for less than their allotted time, may not cede or yield their time to another commentor. Written comments of individuals who cannot be physically present may not be read aloud at the meeting but may be submitted to the Commission.

The subject matter of public comments shall be relevant to matters within the Commission's jurisdiction. Public comment by parties to this proceeding shall not be permitted. The Chair shall retain the right to stop any commentor who raises an issue that is not under the Commission's jurisdiction or is subject to the restrictions above. Public comment shall be received without Commission comment or response. However, individual Commissioners may, at their option, seek clarification or additional information from commentors through the Chair. No commentors will be accommodated after the public comment portion of the agenda has closed. The Chair retains the right to exercise discretion in the implementation of this policy and may override the above rules in case of emergency or other unforeseen circumstances.

Commentors shall at all times conduct themselves in accordance with proper decorum. Profane or vulgar language or gestures shall not be tolerated. Audience members shall not disrupt the public comment hearing by speaking out of turn or without being recognized by the Commission, and shall not incite others to do so. The Commission retains the right to remove disruptive attendees and individuals from the public comment hearing who fail to conduct themselves in accordance with these provisions.

Interested persons who are not affiliated with a party in this Docket may additionally file written comments at any time before the Commission takes final action. Written comments should be sent via email to: PRC.Records@prc.nm.gov.
